Respected Madam / Sir,

Our institute **Shri Datta Shikshan Prasarak Mandal, Panutre A/p. Kale, Tal. Panhala, Dist. Kolhapur** runs Educational programs in **Kale** village of Kolhapur District. It is located in rural, backward and hilly. It is surrounded by 50-60 small villages where there were no facilities of higher education & quality education. Most of parents' occupation is agriculture.

Shri Datta Shikshan Prasarak Mandal, Panutre is an **Educational Charitable Trust Established by Mr. Vitthal Shankar Patil** in the year **1986**. The dream of founder is to give quality education to learners of hilly and backward area.

In this small hilly village called Kale, Sanstha started Girls High School (1991- 1992), Primary School (1992- 1993), Junior Arts College (1995- 1996). There was no Senior College in Kale, as a result student has to go to Kolhapur for higher educational purpose. Students, especially girls are unable to complete their higher education because Kolhapur is away from Kale & lack of money and transportation. So our institute started Varishtha Kala (Arts) Mahavidyalaya for both Boys & Girls in June 2000, which is now named as Vitthalrao Patil Mahavidyalaya (Arts, Commerce and Science) Kale. Hostel for backward class students is started in 2004 – 2005. By considering the need of professional courses we started D.Ed. College in 2006- 2007 and ITI College in 2011- 2012. In 2008- 2009 Sanstha responded to Parents demands by starting English Medium Primary School. Junior college expanded with Commerce and Science faculty in 2010.

In a short period Sanstha expanded considerably. About **2100 students** are taking education now in our institute. We have improved the standard of our school. Institute has appointed well experienced and qualified teaching and non teaching staff. We constructed huge buildings in campus, accommodative classrooms, Library, science laboratories, sports ground, Gymnasium, Residential rooms for poor and needy students free of cost. Total built up area of Institute's building is 4500 sq/ft. 16500 sq/ft. building is taken on lease. Those buildings are used for High School, Senior College, I.T.I. College and Hostel.

Sanstha always responded positively to the Social and Educational need of society. Recently, many parents appealed us to start a Medical Institute. Since this is hilly, rural locality, society around us has less Health related awareness. Financial and educational backwardness causes serious medical problems to people, especially Children, Women and Elder Men. Considering this, we have recently started **SHRI VITTHAL PATIL HOSPITAL AND RESEARCH CENTRE, KALE** to serve poor and needy people of the region.

In the COVID 19 Pandemic Sanstha gave its 40 Bed facility to Local Government Establishment for the medication of COVID-19 Positive patients.

This unit runs in lease building of Shri Datta Shikshan Prasarak Mandal which have own land in Kale Village. Land in GAT No. 788 is 01 Hector 20 Ares and in GAT No. 790 is 00 Hector 18.34 Ares. Total available land is 01 Hector 38.34 Ares. And institute has given 00 Hector 46 Ares land in Kale on registered lease bond for play ground. **We have sufficient land but lack of Funds.**

The main purpose of writing this letter is to request for Financial Assistance/Donations from organizations/Brands Like yours, who care "Literacy Projects and Health Issues" in Rural India. We still need building, beds, furniture, Hospital Equipments and Machinery, Laboratories Material, Books, Computer lab etc. for our newly established **SHRI VITTHAL PATIL HOSPITAL AND RESEARCH CENTRE, KALE.**

At Present we need **Rs. 2,00,00,000/-(Rupees Two cores only)** to carry out our project. For this project first time we have decided to ask for financial assistance from people/organization like yours. Our institute has appealed to the Donors/philanthropists/corporate Houses and agencies to donate generously. **Donations are eligible for exemption u/s. 80 G of Income Tax Act. We also have FCRA Registration certificate to receive donations from abroad.**
